





In the exigency of service, you are hereby designated as Officer-in-Charge of the Office of the Assistant Schools Division Superintendent (OIC-ASDS) in the Schools Division Office of Biñan City, effective immediately and until an Assistant Schools Division Superintendent has been appointed, or unless sooner revoked.

As Officer-in-Charge, you are entitled to the representation and transportation allowances (RATA), except the salary of the position.

It should be emphasized that in order for you to be considered for promotion as a full-fledged Assistant Schools Division Superintendent, you should obtain the required Career Service (CES) eligibility and/or pass the Educational Management Test (EMT) within two (2) years otherwise, this designation will be revoked, and you shall assume your regular plantilla position.
