

These activities are in line with Section 4 of Administrative Order (AO) No. 23 s. 2011, titled "Creating a Steering Committee on National Observances," which gives committee member agencies of the National Steering Committee (NSC), including DepEd, the following powers and functions:

- a) formulate, organize and prescribe the manner of yearly celebrations of historical events;
- b) draw up mechanism among various national departments, local government units, and the private sector for the effective mobilization and coordination of commemorative programs;
- c) monitor, evaluate and submit quarterly reports to the President on all programs of the committee; and
- d) perform such other powers and functions as may be necessary to carry out the provision of this Administrative Order.

In addition, Section 5 of the same AO directs all other government agencies to cooperate with and fully support the NSC, chaired by the NHCP in the exercise of its responsibilities and functions to achieve the objectives of national observances, commemorations, and celebrations.
