

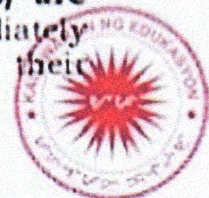
Subject: **DEPED TV BATCH 4 TEACHER-BROADCASTERS**


