

PREPARATION AND CONSOLIDATION OF FY 2022 BUDGET PROPOSALS

Chief, Curriculum Implementation Division (CID)

1. With reference to National Budget Memorandum No. 138, s. 2021 dated January 06, 2021, National Budget Call FY 2022, the Division Budget and Accounting Unit will conduct Division Seminar-Workshop on the Preparation and Consolidation of FY 2022 Budget Proposals at the Division Library Hub on February 23-24, 2021, 8:30 am in cluster-based (copy attached for ready reference)
2. A limited face to face (F2F) orientation will be used in this activity and following the minimum health and safety protocols.
3. The FY 2022 National Budget will reflect continued adaption of the following administrative reforms for greater budget transparency and reliability such as: the continued adoption of the administrative reforms for greater budget transparency and reliability such as Two-Tier Budgeting Approach (2TBA); Unified Accounts Code Structure (UACS); Program-based budgeting structure through the Program Expenditure Classification (PREXC) approach; Disaggregation of lump-sum amounts within the agency specific budgets to reflect the P/A/P, implementing agencies and/or regional or local levels. Agencies are likewise expected to improve their monitoring of priority outputs and results, factoring the "new normal" setting.
4. Participants to this activity are the Budget Officers III, Accountant III, Planning Officer III, Division GAD Focal Person, Administrative Officer IV (HR), Elementary and Secondary School Heads, Schools Property Custodian and Senior Bookkeepers of the Secondary Schools Implementing Units.
5. Food provision expenses of the participants shall be charged against Division MOOE while traveling expenses shall be charged against School MOOE subject to usual accounting and auditing rules and regulations.
