1. In adherence to Regional Memorandum No. 78, s. 2021 with concerns on the Delivery of SLMs to Respective Schools Charged to MOOE, this Office through the Learning Resources Management Section (LRMS) in partnership with the Supply Section informs all the schools on the Ongoing Distribution of Third Quarter SLMs for Key Stage 1.
2. Relative to this, it is expected that the Schoolhead together with the School Inspectorate Team shall abide by the following guidelines.
 - a. **The SDO Biñan through the Supply Officer will notify the Schoolheads through their School Property Custodian on the schedule of distribution.**
 - b. School Inspectorate Team, School LR Coordinator together with the Schoolhead should be available to inspect the resources. They shall be at the forefront to improve efficiency and access to these resources, maximize their use, and minimize/eliminate the damages and/or losses.
 - c. In the Inventory Custodian Slip, the Property Custodian shall sign the portion "RECEIVED" on the specified quantity and item description.
 - d. The Inspectorate Team shall record and document the received items by the school.
3. Transportation expenses relative to this shall be charged against the Schools MOOE, as provided by DepEd Order No. 15, s. 2020, subject to the existing budgeting, accounting, procurement, and auditing rules and regulations. See attached enclosure.




