Pursuant to DM-PHROD-2021-0081 entitled Conduct of the National Qualifying Examination for School Heads (NQESH) 2021 and in line with the implementation planning of SDO Biñan City's **Project UNLEASH (Unified Leadership Advancement for School Heads)**, this Office announces the conduct of **REVIEW FOR 2021 NQESH TEST TAKERS from June-August 2021**.

2. Interested test takers who would like to participate in the review sessions must meet any of the following experience requirements as stated in DepEd Order No. 39, s. 2007 entitled, Modified Qualification Standards for the Positions of Head Teachers and Principals while waiting for the official and updated criteria of the examination:

- one (1) year as Head Teacher; or
- two (2) years as Teacher-In-Charge; or
- two (2) years as Master Teacher; or
- five (5) years as Teacher III or SPED Teacher; or
- five (5) years as incumbent public school teacher who has five years of managerial and supervisory experience in a DepEd-recognized private institution or Commission on Higher Education (CHED) recognized higher education institution.

3. Public Schools District Supervisors (PSDSs) shall facilitate the screening and submission of list of test takers who are interested to participate in the review sessions following this template prepared and signed by the PSDS:


