1. 1987 Philippine Constitution, Article XIV, Section 2: states, that the State shall establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society; encourage non-formal, informal, and indigenous learning systems, as well as self-learning, independent, and out-of-school study programs particularly those that respond to community needs; and provide adult citizens, the disabled, and out-of-school youth with training in civics, vocational efficiency, and other skills.

DepEd Order No. 41, s. 2017, is the one of the policies that specify the implementation of programs to support a complete, adequate, and integrated system of education that respond to the needs of every learner in the community. Thus, the Schools Division Office will hold an activity entitled, **Division Orientation Webinar on Inclusive Education: Madrasah/ALIVE, SPED, and Alternative Learning System (ALS)**, on June 25, 2021, at 8:00 A.M to 5:00 P.M via Google and Zoom platform.

 - a. orient SchoolHeads, teachers and other stakeholders on the importance of inclusive education as an alternate approach to learning.
