

**ANNUAL PHYSICAL EXAMINATION OF TEACHING PERSONNEL**

To : Assistant Schools Division Superintendent

All School Heads

1. Pursuant to DepEd Memorandum No. 22, s. 2015 entitled Annual Physical Examination of DepEd Employees (Teaching and Non-Teaching Personnel), this office through the SGOD School Health Section will conduct the annual physical check-up of **All Teaching Personnel** on **August 2 to August 6, 2021** at **Gabaldon Hall, Biñan Elementary School** to ensure that all employees are physically fit to perform their assigned roles and function.
2. Teaching Personnel are advised to subject themselves to the following laboratory examination to the recommended 3<sup>rd</sup> party laboratory provider of the School Health Section:
  - a. Complete Blood Count,
  - b. Urinalysis,
  - c. Chest X-ray PA (except those who are pregnant)
  - d. ECG (if the teacher is 40 years old and above).
3. In preparation to this, an excel file for the master listing of teachers will be provided by the Nurse in charge of your school to be uploaded to this link:

4. These laboratory tests amounting of Five Hundred Pesos (P500) will be shouldered by the teaching personnel as per DepEd Order No.013 s. 2021 "Supplemental Guidelines on Grant of Cash Allowance to Teachers", the school head shall collect the payment for the 3<sup>rd</sup> party Laboratory provider upon completion of the examination.
5. Teachers may use their health card if they intend to go to their preferred 3<sup>rd</sup> party accredited laboratory provider, given that they follow the required tests to be done. All result shall be forwarded to the School Health Section Office.
