Relative to Dangerous Drug Board Regulation No. 5 Series of 2007 re: Institutionalizing the *Barkada Kontra Droga* Program and OUA MEMO 00-1020-0128 re: Transfer of Management and Supervision of *Barkada Kontra Droga* (BKD) Program, this Office through the Youth Formation Section of the School Governance and Operations Division informs all Secondary School Heads on the **Designation of School Barkada Kontra Droga (BKD) Program Coordinator for School Year 2021-2022**.

2. The general objective of the BKD Program is to promote people empowerment in leading a healthy lifestyle that is drug-free and productive. Specifically, it aims to:

- Establish a BKD movement;
- Train the people in advocating a healthy and productive drug-free lifestyle;
- Create a fully drug-free environment in the home, school, workplace and community;
- Encourage productive use of time and alternative activities; and
- Provide support services towards the adoption of *Barkada* concept among families, educators, professionals, work forces, peer groups, and other sectors.

3. Secondary School Heads must designate a School BKD Program Coordinator who shall:

- Provide/conduct training or seminars on the prevention and control of dangerous drugs among learners;
- Accomplish necessary reports; and
- Others, needed for the implementation.
