**RESUMPTION OF THE IMPLEMENTATION OF THE ONE-TIME CLEANSING OF  
PROPERTY, PLANT AND EQUIPMENT (PPE) ACCOUNT BALANCES IN NON-  
IMPLEMENTING UNIT SCHOOLS**

1. Pursuant to Division Memorandum No. 196, s.2021 entitled "Implementation of One-Time Cleansing of Property, Plant and Equipment (PPE) Account Balances in Non-Implementing Unit Schools" this Office, through the Property and Supply Unit with the assistance of the Accounting and Legal Units, conducted the physical count of Property, Plant and Equipment from July 1, 2021 to July 29, 2021.
2. Last August, 2021 upon recommendation of the Department of Interior and Local Government and IATF after consultation with the local government in Laguna, the province of Laguna was placed under enhanced community quarantine (ECQ) hence, the same activity was postponed on August 3, 2021.
3. On August 21, 2021 the Covid-19 Interagency Task Force (IATF) decided to ease the strict lockdown in Metro Manila and Laguna, lowering the status in both areas to a modified enhanced community quarantine (MECQ).
4. In view of this, the conduct of the physical count of PPE to Non-Implementing Unit Schools as part of the One-Time Cleansing of PPE Account Balances of Government Agencies can now be resumed on **October 27, 2021** up to **December 16, 2021**.
5. Immediate dissemination of this Memorandum is desired.
