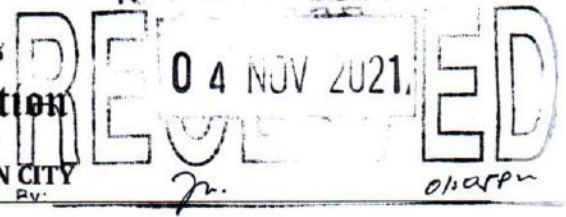

1. Pursuant to DepEd Order No. 12, s. 2020, otherwise known as the Adoption of the Basic Education Learning Continuity Plan for School Year 2020-2021 in Light of the COVID-19 Public Health Emergency, this Office, through the Planning and Research Section of the School Governance and Operations Division, announces the conduct of **Progress Monitoring of School's Enhanced Basic Education Learning Continuity Plan (BE-LCP) on November 17-19, 2021.**
2. The School's BE-LCP is a package of education interventions that responds to basic education challenges brought about by COVID-19.   - d. facilitate discourse and collaboration between schools and the division office in calibrating the BE-LCP to be responsive as possible to the demands brought by COVID-19 pandemic.
