COVID-19 VACCINATION OF PEDIATRIC POPULATION



1. In pursuant to DepEd Memo. No. 28 s. 2021, DTFC Memo. No. 372, 2021 & DOH Dept. Circular No. 048 "Interim Operational Guidelines on the COVID-19 Vaccination of the Rest of the Pediatric Population Ages 12-17 Years Old" this Office through the School Governance and Operations Division-School Health Section is hereby directed all public schools to follow guidelines stated below.
2. DepEd personnel to actively participate in the ongoing implementation of the National Deployment and Vaccination Plan (NDVP) as recipients or beneficiaries, members of the vaccination team or champions for advocacy on vaccination.
3. Voluntary participation of personnel shall not prejudice work in DepEd and shall be approved by their respective heads of offices through a written endorsement to the LGU where the responsibilities and the protection of the personnel are clearly stated.
4. Schools identified as vaccination centers shall prepare identified areas in the school based on the provisions of OM-OSec 2021-03-003 entitled Use of DepEd Classroom and Other Facilities as Vaccination Centers.
5. Submission of required data for masterlisting of learners following the age category as stated. School adviser to assist parents in the pre-registration of their children thru Biñan City website: <https://apps.binan.gov.ph/covacregistration>
6. Eligible learners for vaccination are those without comorbidities to present ID/birth certificate and must be accompanied by parent/adult relative or guardian.
7. Further announcement of schedules can be viewed thru City Health Office/LGU FB pages and communicated by the School Health Section. Initial schedule of vaccinations is attached.
