**SCHOOL-BASED FEEDING PROGRAM (SBFP) SY 2021-2022**

To : Assistant Schools Division Superintendent  
Chief, School Governance and Operations Division  
Chief, Curriculum Implementation Division  
All Concerned School Heads

1. The City Schools Division of Biñan City, through the School Governance and Operations Division-School Health Section (SGOD-SHS), maintains its commitment to provide good nutrition to learners amidst the COVID-19 Pandemic. Pursuant to DepEd Order No. 31, s. 2021, this Office announces the Implementation of School-Based Feeding Program for SY 2021-2022 on January 6, 2022.
2. In consideration of the changes brought about by the pandemic, the implementation of the SBFP has been modified, putting utmost importance to the welfare, safety, and health of learners and personnel involved, while ensuring the attainment of the program objectives. The SBFP shall be implemented in line with the Basic Education-Learning Continuity Plan (BE-LCP) and in strict compliance with the DepEd required health standards.
3. The primary beneficiaries shall be all incoming kindergarten learners, and the Grade 1 to Grade 6 learners who were wasted and severely wasted on the SY 2020-2021 SBFP report, except those who have moved to Grade 7. The program shall provide beneficiaries with nutritious food products for 50 days and pasteurized milk for 27 days.
4. Distribution of Colgate Oral Health Bundle to kindergarten learners-beneficiaries shall take place on the first week of SBFP Implementation.
5. SBFP Coordinators shall attend the pre-implementation meeting on January 4, 2022, 1:00 PM via Google Meet virtual platform to make sure that School-Based Feeding Program Implementation is effective and efficient. Meeting link shall be posted on SBFP-Biñan City chatgroup one (1) day before the said date.
